1. All drivers must have a valid NEW JERSEY driver's license, car registration and proof of insurance.
2. Parking on school grounds during school hours is limited to seniors. **Parking for seniors will be restricted to the area adjacent to the football field and cafeteria but not along the fence on the cafeteria side.**
3. All automobiles parked on school grounds must be registered with the school and display a current decal on the inside driver's side rear window. All unauthorized/unregistered vehicles will be subject to being towed at the owner's expense.
4. **THERE WILL BE ASSIGNED PARKING SPOTS.** Students must park in the student parking area and not use other parking areas (Front parking spaces, rear of high school, middle school and administration building). Students will face loss of privileges and or/will result in the car being towed from school premises.
5. The school is not responsible for the vehicle or its contents. **Lock your doors and close your windows.**
6. There will be no loitering in the parking lot. **No speeding (5 miles per hour) or RECKLESS DRIVING. SPEEDING (ABOVE 5 MILES PER HOUR) AND RECKLESS DRIVING ARE NOT ACCEPTABLE.**
7. Winslow Township High School is a closed campus. Students are **NOT** permitted to leave school property, or exit the building at any time during the school day without the approval of the Assistant Principal.
8. Any student who visits their vehicle or the parking lot without first obtaining permission from the Assistant Principal, and/or is suspected of any form of misconduct in the parking lot, may have the vehicle in question immediately searched.
9. **Students who continually fail to arrive on time will have their parking privileges suspended. First offense-three lateness's a thirty day suspension; Second offense-continual lateness, suspension for the marking period; Third offense-habitual lateness revoking of senior parking privilege.**
10. It is a senior privilege to park on school grounds. Suspension of parking privileges, towing of vehicles, suspension from school, and/or police action may occur if the above regulations are violated.
11. Students are not permitted to drive in the loop in front of the building or in the teacher's parking lot when buses are present. Students are not permitted to drive behind the school and gymnasium.
12. Students are not permitted to park in the county library, Senior Citizens lot, or on any surrounding municipal street. Any student parking in these areas faces possible ticketing and /or towing by municipal authorities.
